- If local relatives/friends will sponsor you “in kind” with cost-free accommodation and meals for the duration of your study, you may subtract the equivalent value per year of **US\$ 7,100** from the TOTAL. Please indicate such on the Statement of Financial Responsibility and follow instructions. You must submit a letter, signed by your relatives/friends, along with the Statement of Financial Responsibility, Affidavit of Support, and bank letter, indicating such “in-kind-sponsorship”.

- If legal dependents (i.e. spouse, children) plan to accompany you to UNC Charlotte as F-2 dependents, please provide additional proof of available funding in the amount of **\$5,000** per dependent (per academic year).

- If you plan to enroll in Summer Sessions prior to initial Fall term enrollment, please provide additional proof of available funding in the amount of **\$5,500** per Summer Session.
